Notes:

1. Represents the increase in certified capacity from the prior month's SRECTrade SREC Markets Report. MA represents the increase from the last DOER report on 9/23/11.
2. CY=Calendar Year, EY=Energy Year. DE, NJ, and PA energy years run from June 1 - May 31
3. Estimated Required Capacity - Current and Next Reporting year reflects the total capacity that must be running on average throughout the year to meet the solar requirement in that year. Figures based on RPS requirements, EIA data, and SRECTrade estimates. MWhs are converted to megawatt capacity requirement at a rate of 1,200 MWhs in PJM and 1,130 MWhs in MA per year per MW. MA estimates take into consideration the impact of the TransCanada settlement.
4. Up to 50% of the OH requirement can come from bordering states. The total MWhs reference is for the entire RPS requirement.
5. Total Certified Systems - All PJM Markets: These figures do not equal the sum of total certified capacity and quantity of projects greater than 1 MW due to systems certified in multiple states.
